This guideline was developed to support beneficiaries awarded with grants within the scope of the Formal Employment Creation Project, to fulfill the necessary visibility responsibilities in the activities they carry out within the scope of the grant program. The rules and examples in this guide can be taken as basis to ensure that all activities to be carried out throughout the project are carried out within the framework of visibility rules.

GENERAL RULES FOR LOGO USE

Logo use under the Project activities has been grouped under 3 main categories:

- 1. EU Emblem Logo Use (Just EU emblem)
- 2. Cooperation/Partnership Logo Use (Just EU Turkiye waving flag)
- 3. Cooperation/Partnership and Stakeholder Logo Use (All logos)









1. EU Emblem Logo Use (Just EU emblem)

Materials and products purchased with the EU funds to be used by the beneficiary or office supplies to be used by partners must bear the EU emblem logo.

The EU emblem logo must be accompanied by the following statement in English, Turkish and Arabic:

"Funded by the European Union."

Sample areas fort he use of the EU emblem logo are listed below:

- Information Screen
- Laptop
- Printer
- Personnel/Manager Desk
- Desktop Computer (Monitor and Case)
- Chief/Officer/Personnel/Meeting/Guest Chairs
- Executive Chair and Desk
- Guest Waiting/Hosting Sofa Sets
- Kiosk
- File Cabinets With/Without/Glass
 Doors





2. Cooperation/Partnership Logo Use (Just EU – Turkiye flag)

A common logo was designed for projects other than humanitarian aid implemented in Turkiye within the scope of FRIT. Projects other than humanitarian aid financed or co-financed by the EU in Turkiye are requested to use this logo in all their visibility activities.¹

The EU-Turkiye partnership logo must be accompanied by the following phrase in English, Turkish and Arabic:

"Funded by the European Union."²

Example:



In order to use the EU-Turkiye joint logo correctly, the logo should not be copied, and downloaded only from the relevant link on the European Union Turkish Delegation at *https://www.eeas.europa.eu/delegations/t%C3%BCrkiye/visibility-guidelines-clarification-2022-guidelines-communicating-and-raising-eu-visibility_en_*where the logo can be found in several different formats.

² Exceptions may be made to this rule depending on financial arrangements.



¹ Exceptions to this rule are only possible with approval from the EU Turkiye Delegation.



3. Cooperation/Partnership and Stakeholder Logo Use (All logos)

All visibility materials, particularly those suitable for external sharing, for awareness raising or communication activities produced within the scope of the Project should carry logos of Development and Investment Bank of Turkiye and The World Bank Group, as well as Project logo (Kayist) in addition to the EU-Turkiye partnership logo, placed accordingly to the design. All materials within this framework are expected to be used with approval from the Project communication team.

Sample areas of use are listed below:

- Vehicles
- All printed and visual visibility materials (Poster, brochure, stage, e-bulletin, bulletin etc.)
- Outdoor TV
- Certificate
- Sign (Exterior and interior of the building)
- Meeting room (Furnishing information)

In cases where Cooperation/Partnership and stakeholder logos are used together, the placement of the logos shall be carried out according to the following rules.

In the 3-way logo layout, the EU-Turkiye partnership logo is placed centered at the top, the Project logo is centered just below, and the 2 stakeholder logos are placed centred at the bottom, as shown in the picture.












Details about the use of logos in cases where all logos will be used together are shared below.

- EU-Turkiye Cooperation Logo: Within the scope of FRIT, the EU-Turkiye joint logo must be accompanied by the phrase "*Funded by the European Union*" in English, Turkish and Arabic.
- The logo in question should be used in the dimensions and proportions demonstrated in the images below.
- The EU-Turkiye partnership logo should always be located at the top in the center or in the upper left corner.
- Stakeholder Logos: The stakehodlers within the scope of this Project are Development and Investment Bank of Turkiye and the World Bank.
- Logos of these institutions should be placed on the visible surface of the material, at the bottom with TKYB logo on the left and the World Bank Group logo at the right, both centered and equal sized, with the EU-Turkiye partnership logo at the top center.
- Stakeholder logos must be no larger than half of the EU-Turkiye partnership logo.
- Project logo: If the Project logo is used, the logo should be centered just below the EU-Turkiye partnership logo and should be no larger than stakeholder logos.

The proportionate sizes of all logos are specified below.


